



Figure S2: The cumulative distribution of p-values in genome-wide scans for all phenotypes. The different curves correspond to different approaches for correcting for population structure (described in Table 2). Without correction for population structure, all p-value distributions are strongly skewed towards significance. These results are for associations between phenotype and haplotypes (cf. Figure 2).
